## **Indianapolis 500 Race Day Ticket NFT**

2022 Indianapolis 500 ticket holders are eligible to redeem the 2022 Indianapolis 500 Race Day Ticket NFT (the "Race Day NFT"). Ticket account holders will receive an e-mail or other instructions from the Indianapolis Motor Speedway starting at approximately 3pm ET on

Thursday, May 19, 2022, which will include a link to a page on Autograph.io where you can claim your Race Day NFT, and instructions on what to do next. The e-mail will be directed to the e-mail address that you provided to purchase your Indianapolis 500 ticket. Timing of when you receive your e-mail or other instructions may vary; please contact WingandWheel@brickyard.com if there are any issues with your receipt of your e-mail or other instructions. After you receive your e-mail and ending at 11:59 p.m. ET on May 30, UPDATED: June 3, 2022 (the "Indianapolis 500 Race Day NFT Redemption Period"), you may follow the link in the e-mail to redeem your Race Day NFT. After following the link, if you already have an account on Autograph, you will be prompted to log in, or, if you do not have an account, you will be prompted to create one. After account log-in or creation, you will be redirected to a page where you can redeem your Race Day NFT by providing the Redemption Code included in the email from the Indianapolis Motor Speedway. The Race Day NFT may be visible in your Autograph account within 24 hours. The Race Day NFT is a souvenir of your attendance at the 106th running of the Indianapolis 500. Each Race Day NFT has a monetary value of \$0.

## 2022 Indianapolis 500 Mystery Driver Container:

Autograph will offer 1,089 2022 Indianapolis 500 Mystery Driver Containers (each a "Container") for sale at a price of \$50 per Container for The 2022 Indianapolis 500 Collection. Each Container will hold one (1) Collectible inside that relates to one of the 33 drivers competing at the Indianapolis 500 (each a "Driver Collectible"). Each Driver Collectible inside a Container is randomly determined (consistent with the Edition Counts in the table below) and will not be revealed until after the user opens the Container. Containers can only be opened after the Reveal Date set forth above. Users do not need to open a Container once purchased, and may re-sell a Container unopened, although only holders of opened Containers that reveal the Driver Collectible are eligible to receive the utility for the 2022 Indianapolis 500 Mystery Driver Container as explained below. # **NFT Utility:**

Utility for #2 - 2022 Indianapolis 500 Mystery Driver Container

A person who (i) holds a 2022 Indianapolis 500 Mystery Driver Container that they have opened to reveal a Driver Collectible at 12:30pm ET on May 29, 2022 (the "Activation Deadline") or such other time as determined by Autograph in its sole discretion; (ii) has established and maintained in good standing an Autograph user account before the Activation Deadline; and (iii) has successfully linked their DraftKings account to their Autograph account before the Activation Deadline (criteria (i), (ii) and (iii) in the foregoing sentence are collectively the "Utility Eligibility Criteria," and each user who satisfies such criteria, an "Eligible User") shall be eligible for the following utility. Autograph will share this information with INDYCAR to arrange for the delivery of the Container Utility, to the location directed by the Eligible User. Providing the requested information is a necessary condition to fulfillment of the Container Utility; if Autograph is unable to contact and receive a response enabling fulfillment from a Eligible User after undertaking a reasonable effort to contact such Eligible User or if a Eligible User declines to supply the necessary information, Autograph and INDYCAR reserve the right to retain the applicable Container Utility and/or otherwise dispose of it in its sole and exclusive discretion.
