By purchasing, redeeming or receiving a Collectible, you agree to be bound by these Terms & Conditions in addition to Autograph's Terms of Service at https://go.autograph.io/tos; if you do not agree to these Terms, please do not purchase, redeem or receive a Collectible.

The 1-of-1 Graffiti Artist Collectibles (#1 in the table above) will be sold by timed auction on (and administered by) OpenSea, a Third Party Platform. Per <u>OpenSea</u>, the auction will sell the NFT to the highest bidder (also known as an English auction). All bids must be at least 5% higher than the previous bid and only bids in the same payment token as the auction will be counted towards the winning bid. The auction is anticipated to start at 1 p.m. Eastern Time on Friday, March 25, 2022. To begin bidding, you must place a bid equal to or greater than the minimum bid.

The auction is scheduled to end at 3 p.m. on Monday, March 28, 2022, but any bids made in the last 10 minutes of an auction will extend that auction by 10 more minutes. Popular auctions are often extended by new bids offered in the last 10 minutes and may be extended for up to a week. By participating in this auction, you agree to be bound by the outcome of the bidding as determined by OpenSea in its sole and exclusive discretion. The bidder who OpenSea determines, in its sole discretion, has the highest (i.e., "winning") bid as of the end of the auction is the "Auction Winner."

Commemorative NFTs

To be eligible for the BUKU x Autograph 2022 Commemorative NFT (the "Commemorative NFT"), you must have purchased a ticket to or registered a wristband for BUKU 2022, establish an Autograph account, link your External Non-Custodial Wallet to your Autograph account, and consent to the AEG opt-in during the redemption user flow, as explained below.

After you receive your e-mail or other instructions, but no earlier than April 9, 2022 at 12:01 a.m. Pacific Time, and ending at 11:59 p.m. Pacific Time on April 15, 2022 (the "Commemorative NFT Promotion Period"), you may follow the link in the e-mail to a user redemption flow. If you already have an account on Autograph, you will be prompted to log in, or, if you do not have an account, you will be prompted to create one. You must then link your External Non-Custodial Wallet to your Autograph account if you have not already done so. Currently, Coinbase Wallet, MetaMask Wallet and WalletConnect can be associated with your user account on Autograph.io; for instructions on how to do so, please visit this blog post. After account log-in or creation and linking your External Non-Custodial Wallet, as applicable, you will be redirected to a page where you can redeem your unique link. The Commemorative NFT may be visible in your Autograph account within 24 hours. The Commemorative NFT is a souvenir of your attendance at BUKU 2022. The Content associated with your Commemorative NFT will be one of six variations, which will be allocated sequentially to eligible recipients (i.e., the first user in line gets version number one, the second user in line gets version number two, the third user in line gets version number three; after a user receives version number six, the next user in line receives version number one, and so on). By redeeming your unique link, you agree to accept any one of the six potential variations of Content. Make Your Own NFTs

Autograph will have a sponsor booth at the 2022 BUKU festival in New Orleans. Attendees to the 2022 Buku festival can visit the Autograph booth and create a BUKU 2022 by You Make Your Own NFT (the "Make Your Own NFT") using a tablet to select and arrange pre-selected creative elements, including BUKU photographs and artists' graffiti tags (the "Make Your Own NFT Creation Process"). One (1) Make Your Own NFT per person. When you create a Make Your Own NFT, you own the NFT but you do not obtain or possess any intellectual property rights in the Content of the Make Your Own NFT, including any rights in underlying elements and/or selection or arrangement of such elements, except for the license grants expressly set forth in Section 5 ("License to Content") of the Autograph Terms of Service. As between Autograph and you, Autograph retains all right, title and interest in and to the Make Your Own NFT and any and all associated creative elements, including, but not limited to, use for marketing and advertising purposes.

If you already have an account on Autograph, you will be prompted to log in, or, if you do not have an account, you will be prompted to create one. You must then link your External Non-Custodial Wallet to your Autograph account if you have not already done so. Currently, Coinbase Wallet, MetaMask Wallet and WalletConnect can be associated with your user account on Autograph.io; for instructions on how to do so, please visit this blog post. NFT Utility:

Utility for #1 - 1-of-1 Graffiti Artist NFT

The Auction Winner of each "1-of-1 Graffiti Artist NFT" Collectible shall be eligible to receive: (i) two (2) VIP tickets to BUKU 2023; and, for so long as the Auction Winner continues to hold their 1-of-1 Graffiti Artist NFT, (ii) access to the private Discord community; and (iii) access to unlockable scenes from BUKU 2022 (items (i), (ii) and (iii) are collectively the "Graffiti Artist Utility"). In order to be eligible for the Graffiti Artist Utility, you must establish an Autograph account and link the External Non-Custodial Wallet that is holding the 1-of-1 Graffiti Artist NFT to your Autograph account. By purchasing a 1-of-1 Graffiti Artist NFT and completing the foregoing steps, you consent to allow Autograph to share collected information with AEG. Autograph will send an email at a later date with further instructions to access the private Discord community. For clarity, only a current holder of a Commemorative NFT will have access to the Commemorative NFT Utility; if a recipient of a Commemorative NFT ceases to hold that Collectible, the original recipient will no longer have access to the private Discord Community or unlockable scenes, and this utility will transfer to the then-current holder of such Collectible.

Utility for #3 - Make Your Own NFT

In order to be eligible for the Make Your Own NFT Utility (defined below), you must establish an Autograph account, link your External Non-Custodial Wallet to your Autograph account, and opt-in to data sharing with AEG through the redemption user flow. community; and (ii) access to unlockable scenes from BUKU 2022 (items (i) and (ii) are collectively the "Make Your Own NFT Utility"). Autograph will send an email at a later date with further instructions to access the private Discord community.
